



# WINDSOR AND DETROIT FAN TRIP

## Saturday, November 4<sup>th</sup>, 2017

The Toronto Transportation Society will be chartering a Transit Windsor Orion VI for a five hour fan trip. This series of bus is expected to be retired in early 2018 when Nova LFS buses arrive.

The fan trip will cross the US Border (via the Windsor Tunnel). While in Detroit, we will visit the Rosa Parks Bus Terminal, serviced by DDOT and SMART. TTS members will have the opportunity to ride the new Q-Line Streetcar (a short walk from the terminal) as well as the Detroit People Mover. TTS members **MUST HAVE A VALID PASSPORT** (or enhanced driver's licence or NEXUS card) with no criminal record to attend this event. Upon returning to Windsor, some fall colour photo stops will be scheduled if time permits.



VIA train 71 departs Union Station in Toronto at 6:45 AM on Saturdays arriving in Windsor at 11:02 AM. Returning home, VIA train 78 departs Windsor at 5:45 PM arriving at Union Station at 9:51 PM.

The fan trip will start at the CACC (West End) Terminal (College Avenue, west of Huron Church) at **11:30 AM**, returning at **4:30 PM**. The fan trip will pick up at the VIA station at 11:50 AM, returning at 4:10 PM, Please note that an official lunch break **will not** be scheduled but there will be opportunities in downtown Detroit to get something to eat. In the event that enough members register to require two vehicles, then a first generation Nova LFS will be requested as the second vehicle. If this is the case, one bus will start at the West End Terminal with the other bus starting at the VIA station. Both buses will depart at **11:30 AM** meeting downtown, prior to crossing the border.
